RESOLUTION No. 11/12-15

TITLE: A RESOLUTION AUTHORIZING THE MUNICIPAL COURT TO ESTABLISH AND REVISE FEES FOR TRAFFIC VIOLATIONS AND TRAFFIC SCHOOL PROGRAM FEES.

WHEREAS, the Dayton Municipal Court was established by the City Council and has jurisdiction to adjudicate all State Motor Vehicle Code violations which occur within the city limits of Dayton, Oregon; and;

WHEREAS, the State of Oregon has restructured its Schedule of Fines on Violations as of January 1, 2012 and the City desires to revise it's existing fee structure to conform with State standards and;

WHEREAS, the City desires to establish new fees for the Traffic School Program; and

WHEREAS, the City of Dayton as the legislative body for the City, may adopt enactments that establish authority for the Municipal Court.

NOW THEREFORE the City of Dayton resolves as follows:

- 1. The Dayton City Council makes the following findings:
 - a. The City finds new fees and assessments are necessary to effectuate the City's goals;
 - b. The Court is authorized to establish and levy the fees and assessments through a General Order of the Court: and
 - c. The Court is directed to establish a Uniform Presumptive Fine Schedule to include the attached fine revisions and assessments.
- 2. The Dayton City Council authorizes and adopts the revisions to the Traffic School Program as set forth in General Order 2012-008, attached as Exhibit A..
- 3. The Dayton City Council authorizes the the Municipal Judge to adopt, amend and enforce General Orders of the Court; and
- 4. This resolution shall become effective immediately upon adoption.

RECITALS

- 1. The Dayton Municipal Court has jurisdiction to adjudicate all State Motor Vehicle Code violations which occur within the city limits of Dayton, Oregon.
- 2. The 2011 State Legislative Assembly enacted new laws that change base fine amounts and language, establishing presumptive, minimum, and maximum fine amounts for violation offenses in Oregon effective January 1, 2012.
- 3. The Court established a Traffic School program through General Order No. 2007-001 and desires to revise the existing fees.
- 4. The Dayton City Council has adopted Resolution No. 2011/12-15 approving revisions to the Municipal Court Fees.

IT IS ORDERED AS FOLLOWS:

- 1. The City adopts the State 2012 "Schedule of Fines" on Violations (SOF-12) pursuant to HB 2712 to be effective January 1, 2012 for all violations occurring on or after that date.
- 2. General Order No. 2009-007 Section 4 authorizing a \$20 City Assessment is repealed in its entirety pursuant to HB 2712.
- 3. General Order No. 2009-007 WHICH SECTIONS? is amended to reflect an increase in fees to the court for administration of the Traffic School program as follows: \$75.00 for Class "D" violation; \$120 for a Class "C" violation; \$220 for Class B violation.
- 4. Attached as Attachment 1 and incorporated by reference herein is an amended Dayton Municipal Court and Violations Bureau Fine and Assessment Schedule.
